MINUTES:

*Motion by K. Stevens, seconded by L. David, to approve the minutes from November 23, 2015. Vote, All in Favor, motion passed unanimously.*

**WORK SESSION:**

STONE RIDGE DEVELOPMENT / 27 TURKEY PLAIN ROAD / SITE PLAN-NEW CONSTRUCTION

Mr. Heitschew presented a plan with revisions requested by Wright-Pierce memo, dated December 7, 2015. Mr. Heitschew explained all the work is outside the 100' setback. Chairman Goodrich requested an orange fence be installed along the 100' setback by the well area.

*Motion by K. Stevens, seconded by D. Goodrich, to issue the permit, with conditions as stated in memo, dated December 9, 2015. Vote, All in Favor, motion passed unanimously.*

CASE / 8 STONE DAM ROAD / PHRAGMITES REMOVAL PLAN / MAINTENANCE

Agent Cavagna reported on a large 8 acre pond with Phragmites pockets along the perimeter of the pond. Resident is hiring Northeast Diving Services for Phragmites removal using environmentally friendly equipment.

*Motion by D. Goodrich, seconded by K. Stevens, to charge the Inland Wetlands agent with supervising the removal of invasive vegetation and maintenance of the pond at 8 Stone Dam Road and report progress to the Commission until completion. Vote, All in Favor, motion passed unanimously.*

Agent Cavagna reported she will be emailing the Inland Wetlands regulations to the Commission for their review.

*D. Goodrich made a motion to adjourn at 7:35 p.m., seconded by K. Stevens. Vote, All in Favor, motion passed unanimously.*
