First Selectman Burke made a motion, which was seconded by Selectman Szatkowski, that:

RESOLVED that Laura L. Vasile, Director of Health, is authorized to make, execute, and approve on behalf of this town, any and all contracts or amendments thereof with the State of Connecticut Department of Public Health to plan, promote and conduct a moderate intensity aerobic exercise program for twelve (12) weeks in the Fall, 2007 and twelve (12) weeks in the Winter, 2008, for two times per week with a self monitored third class for the residents of Bethel, the program to be named Body by Bethel.

RESOLVED that the Town of Bethel hereby adopts as its policy to support the nondiscrimination agreements and warranties required under Connecticut General Statutes 4a-60(a)(1) and 4a-60a(a)(1), as amended in State of Connecticut Public Act -7-245 and sections 9(a)(1) and 10(a)(1) of Public Act 07-132, as those statutes may be amended from time to time.

Vote, all in favor, motion unanimously approved.

2.) Consideration of Resolution – Senior Center Air Conditioning Grant

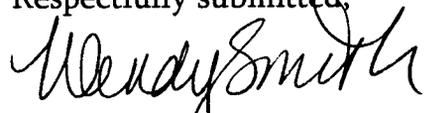
First Selectman Burke made a motion, which was seconded by Selectman Szatkowski, that:
