EMS Report:

There were 82 calls for the month of July, 2021, giving us 576 calls for the year, compared to 578 in 2020

(a less than 1% decrease). In July:

14 volunteers provided at least 8 hours of EMS on-call coverage.

25 volunteers made at least 1 call.

The top responding officers were:

- o Chief John Baker with 22 calls
- o Capt. Matt Gunter with 10 calls
- o Chief Engineer Patrick Magyar and EMS Captain Mangi with 7 calls each

The top responding members were:

- o Chuck Cywin with 15 calls
- o Justin Solipa with 9 calls
- o Ernie Leclercq with 6 calls

ERM made 33 calls as a complete crew.

ERM completed the crew with an EMT on 19 calls.

Of the 82 calls,

- o 39 were BLS (do not include calls where care was transferred as they could be ALS)
- o 24 were ALS
- o 4 were RMA's (include this number with BLS calls)
- o 7 were treated and refused transport (include this number with BLS calls)
- o 3 were treated and care transferred (Stony Hill 2nd call, assist, or A3 OOS)
