#### APPROVAL OF MEETING MINUTES:

### Regular Meeting Minutes of December 11, 2024:

N. Ryan made a motion, seconded by D. Olson, to approve the Regular Meeting Minutes of December 11, 2024, as submitted. Vote, All in Favor, Motion passed.

N. Ryan reported the Board of Selectmen met last night and appointed members to the Commission. David Resendes was appointed to fill the G. Roche vacancy. D. Olson was re-appointed.

#### **OLD BUSINESS:**

#### **Police Station Training Range:**

<u>Project Update:</u> N. Ryan reported CES performed the final commissioning of the range in December. The MAU is reportedly operating in unoccupied mode and Lt. Libertini is working with Action Target on the settings. N. Ryan, also, reported the Eversource incentives of approximately \$30,000.00 had not been received by the Town. They are working on submitting required documents to complete this process.

Budget Review: N. Ryan reported not much change in the budget.

#### Invoice Review and Approval:

N. Ryan made a motion, seconded by D. Olson, to approve CES Invoice #2023352.00.00-0000009, dated December 31, 2024, in the amount of \$2,800.00, for Commissioning from 11/24/24 to 12/28/24. Vote, All in Favor, Motion passed.

#### Invoice Review and Approval:

N. Ryan made a motion, seconded by D. Olson, to approve STV Invoice #90032932, dated December 24, 2024, in the amount of \$1,001.00, for professional services rendered from August 24, 2024 to November 29, 2024. Vote, All in Favor, Motion passed.

#### **BHS HVAC Upgrade:**

Project Update: N. Ryan reported SavMor's contract is signed. Dr. Carver stated the kick-off meeting is scheduled for Tuesday, January 14<sup>th</sup>. G. Hoerauf reviewed the four proposals for Commissioning. All four proposals are qualified with varying degrees of experience on school projects and Connecticut based projects. The RFP analysis focused on price, project approach, experience and previous performance. The lowest bidder, FST, does not have any experience in Connecticut. This is a concern due to the Connecticut State requirements associated with this project. Of the four, SES and Colliers had the most experience with Connecticut school projects and in-depth response. SES's price includes two days for re-testing equipment if there are any failures during initial testing.

SES came in at \$28,000.00 with Colliers at \$48,000.00. STV recommends SES for the project.

N. Ryan made a motion, seconded by D. Olson, to approve and retain Sustainable Engineering Solutions, LLC (SES) for the Bethel High School HVAC Upgrade Project. Vote, All in Favor, Motion passed.

<u>Budget:</u> G. Hoerauf reviewed the budget and will be adding to Construction Administration Kohler Ronan's consulting fee to the budget. Dr. Carver explained the reasons for this addition. G. Hoerauf will also be adding the \$120,000.00 Alternate #2 – exhaust fan. The Commission determined the budget looks good, as presented. M. Dupre reviewed the invoice process and noted Rick will be replacing Michael Duane at the meetings.

#### Invoice Review and Approval:

N. Ryan made a motion, seconded by D. Olson, to approve STV Invoice #90032832, dated December 11, 2024, in the amount of \$3,311.00, for professional services rendered from November 2, 2024 to November 29, 2024. Vote, All in Favor, Motion passed.

N. Ryan made a motion, seconded by D. Olson, to approve Kohler Ronan, LLC Invoice #22021.02-18, dated November 30, 2024, in the amount of \$3,550.00, for professional services rendered through 11/30/24. Vote, All in Favor, Motion passed.

N. Ryan made a motion, seconded by D. Olson, to approve Kohler Ronan, LLC Invoice #22021.02-19, dated December 31, 2024, in the amount of \$3,662.50, for professional services rendered through 12/31/24. Vote, All in Favor, Motion passed.

# Bethel High School HVAC Mechanical Upgrades Project Commissioning Agent Proposal Evaluation

The Request For Proposals for Commissioning Agent issued by the Town November 14<sup>th</sup>, included the following criteria for the evaluation of Cx proposals:

- Price
- Experience with work of similar size and scope
- Past performance/references
- Project Schedule

We have reviewed each proposal against the requirements of the RFP and created the attached matrix consolidating all relevant information for each respondent. As a summary of our review, we offer the following:

Proposed lump sum price was provided by all four firms. Cost ranked from lowest to highest is listed below:

•	FST	\$23,218
•	SES	\$28,000
•	Catalyst	\$29,100
•	Colliers	\$48,390

All firms fulfill the minimum requirements of the RFP and all firms are qualified for consideration as the Commissioning Agent for the project. All firms have the requisite experience and certifications in commissioning activities for comparable school building renovations. The two firms with the greatest experience with commissioning school work in Connecticut are SES and Colliers.

Two of the firms are located in Connecticut (SES and Colliers) and include significant portfolio examples of work for Connecticut public school systems. One firm, FST is headquartered in New York City and also has done school work in Norwalk and Danbury. The fourth firm, Catalyst is headquartered in Pennsylvania, although has committed a Connecticut resident as the lead project manager. Location can

be considered in evaluating response time and commitment to the project. It will also be important to consider experience with CT State grant compliance in the contract award.

Based on our review of the proposals, SES describes the most complete Project Approach and scope of services. Colliers was the only firm to include a potential timeline (not specifically required in the RFP). All firms have committed to the current project schedule.
