1. Footings
2. Pool Bonding before any concrete or other covering is applied.
3. Any underground electrical wiring before it is buried.
4. Observation of gas or oil lines tested with gauge set for required test pressure and before burial.
5. Final Inspection after all work is completed including pool fencing and door alarms.
