Consideration of purchasing the Chief's vehicle for Stony Hill Fire Department in the amount of \$63,908.66. from the CNR account:

Motion made by John Lennon, and seconded by Cynthia McCorkindale, to approve the purchase of the Stony Hill Fire Department Chief's command vehicle in the amount of \$63,908.66 from the CNR account. Vote, all in favor. Motion carries.

Consideration of funding allocation for Stony Hill Fire Department's Fire Truck for the purchase amount of \$1,706,000:

Chair Nick Ellis gave a brief overview of the process that has taken place thus far to purchase the fire truck. Motion made by John Lennon, and seconded by Cynthia McCorkindale, to approve the purchase of the Stony Hill Fire Truck in the amount of \$1,706,000., with \$500,000. coming from ARPA funds, leaving a balance of \$1,206,000. to be paid for from the fund balance. Vote, all in favor. Motion carries.

Comptroller Heering reviewed the report and gave an update on the fund balance and CNR accounts. Discussion ensued. Motion made John Lennon, and seconded by Cynthia McCorkindale, to accept the Comptroller's report as presented. Vote, all in favor. Motion carries.
